NOTE:

* Bodies Corporate under Category A (2) - Foreign consists of two wholly owned subsidiaries of ING Bank N. V. namely (1) ING Mauritius Investments I (9.78%) and ING Mauritius Holdings (34.15%). The first body corporate enjoys full voting rights of 9.78%. The voting rights of second body corporate is governed by Section 12(2) of the Banking Regulation Act, 1949 which says that no shareholder holding shares in a banking company shall, in respect of any shares held by him, exercise voting rights (on poll) in excess of ten per cent of the total voting rights of all the shareholders of the banking company. As such voting rights of the second body corporate is restricted to 10%. Thus the aggregate voting rights of Foreign bodies corporate stand at 19.78%.
