

## **NEW net-banking platform (BBOnline) Slogan Contest**

### **What's New ?**

We are running **NEW net-banking platform (BBOnline) Slogan Contest** where-in customers will get an opportunity to win an iphone.

### **Who can Participate?**

All Retail Current account/OD/CC/Term Loan customers. Customers who have already registered for the NEW net-banking platform are also eligible to participate for this contest.

### **How to participate?**

To qualify for the Offer, the customer needs to do the following:-

- a. The customer has to ***sign up*** for the NEW net-banking platform (BBOnline) by visiting the nearest Branch and post receiving the PIN, ***login*** to the NEW net-banking during the contest period.
- b. The customer has to ***complete the slogan – “I like the NEW net-banking because \_\_\_\_\_”*** and send to the Bank from within the NEW net-banking using option – General Services -> Mail -> Compose Mail. The mail has to be sent to ‘Customer Service’. Only one slogan (first one sent) per user id will be accepted.

### **Offer Period**

Slogan can be submitted till 30<sup>th</sup> November 2011 by the customer.
